- 3. There is delay for more than 02 years, 08 months and 15 days in filing this Original Application as reported by the Registry. Delay Condonation Application has been filed by the applicant. Orally, the learned counsel for the respondents has raised objection that the delay in filing Original Application has not been properly explained. Besides the above, the respondents have objection regarding maintainability of the O.A. before this Tribunal. It is submitted by the learned counsel for the respondents that Writ petition bearing Writ-C 28062 of 2019 was filed by the applicant before the Hon'ble High Court, which came to be disposed of vide judgment and order dated 12.9.2019 with a direction to the respondents, therein to consider and decide the representation of the applicant within a period of one month. It is further submitted that the applicant has not filed Contempt petition before the Hon'ble High Court against the respondents for non-compliance of judgment and order dated 12.9.2019.
- 4. Learned counsel appearing on behalf of the applicant submits that the delay was neither intentional nor deliberate, but it was bonafide and beyond the reach and control of the applicant. The reasons/grounds has properly been explained in delay condonation application. Regarding objection for not filing the Contempt petition, it is submitted by the learned counsel for the applicant that due to lapse of limitation period, he could not file the Contempt petition before the Hon'ble High Court. He further submits that for non-compliance of the order of Hon'ble High Court, there is no bar before this Tribunal to entertain the instant O.A.

5. Considering the rival submissions made by learned counsel for the parties, we are of the considered view that the Objection as raised by the respondents' counsel regarding maintainability of the O.A. is not legally sustainable and is accordingly turned down. As such, this Tribunal has got jurisdiction to entertain the above O.A. Accordingly, MA. stands disposed off in the above terms.
