Priti Tyagi, Departmental Representative.</p> <p>The case has been taken up in the revised list.</p> <p>Heard learned counsel for the parties on the question as to whether the Original Application preferred by the applicant is delayed or not since as per office report this O.A. has been filed delayed by 1 year, 7 months and 29 days.</p> <p>The stand taken by Shri Rohit Kumar, learned counsel for the applicant is that the rejection order 3.5.2012, passed by the Chief of the Army Staff on the petition filed by the applicant under Section 164(2) of the Army Act was never served upon the applicant.</p> <p>The affidavit filed by the respondents in support of M.A. No. 1747 of 2014 indicates that the order dated 3.5.2012, passed by the Chief of the Army Staff, rejecting the petition of the applicant filed</p>

under Section 164(2) of the Army Act was duly communicated to the applicant, vide letter dated 9.5.2012, filed as Annexure No. 'SCA-1' to the affidavit.

While hearing both the sides, learned counsel for the applicant on the one hand submitted that the applicant had not received the aforementioned order dated 3.5.2012, however on the other hand learned counsel submitted that the aforesaid order dated 3.5.2012 was communicated to the applicant by Registered Post, vide aforesaid letter dated 9.5.2012. To clear the controversy involved in this regard, the respondents are directed to produce the original Registered slip before the Court, on the next date of listing, that the aforesaid order dated 3.5.2012 was actually dispatched to the applicant on 9.5.2012.

Learned counsel for the applicant further submits that the applicant had again preferred a petition under Section 164(2) of the Army Act with the plea that while filing the earlier petition under Section 164(2) of the Army Act, the applicant was not in possession of requisite documents.

Learned counsel for the applicant is, therefore, directed to bring on record, in the form of affidavit, true copy of the earlier petition, filed by the applicant under Section 164(2) of the Army Act, on record within two weeks from today.

It also comes out that the petition of the applicant under Section 164(2) of the Army Act was also dismissed on 28.8.2009 by the Chief of the Army Staff which prompted the applicant to amend the prayer clause in the T.A.</p> <p>Since we find that the amendments sought for by the applicant</p>

will not change the nature of the case, we hereby allow M.A. No. 1211 of 2014 with the direction to the applicant to amend the T.A. accordingly within 10 days and file amended copies of the T.A. within a period of one month thereafter, after serving a copy of the same on learned counsel for the respondents.
