No. 63 of 2010 the applicant has filed this Execution Application and on the last date, i.e. on 15.1.2015, Col. Murali Krishna was required to appear before this Court but he did not do so and this Court on the said date, while postponing the case, took a serious note of his deliberate absence and ordered for his appearance for today and, accordingly, Col. Murali Krishna appeared before this Court</p>

today.

On being asked as to why PPO has not been issued and payment in respect of pensionery benefits and other benefits has not yet been made to applicant, Col. Murali Krishna informed this Court that the Government has accorded necessary sanction and for further process some more time is needed. For such lacklustre approach on the part of the Department, this Court, on earlier occasion, ordered to pay the applicant Rs. 1,00,000/- as part of pensionery benefits, which the Department has already paid.

However, since the Department has flouted the order of this Court dated 15.12.2014 wherein Col. Murali Krishna was directed to “*calculate finally the pensionery benefits accruing towards the applicant within a period of one month from today and to ensure that P.P.O. is issued to the applicant within the aforesaid period of one month*” , this Court finds no other option but to direct the respondents to release further Rs. 1,00,000/- in cheque to be deposited before the Registrar of this Tribunal within a period of two weeks, as prayed by Col. Murali Krishna. We order accordingly. But for remaining pensionery benefits and other monetary benefits, as prayed by Col. Murali Krishna, six weeks’ time is granted for issuance of P.P.O. and payment of other monetary benefits to the applicant.

As prayed by Col. Murali Krishna, list this case on 12.3.2015 before this Court for further hearing. It is made clear that by the aforesaid date if P.P.O. is not issued and payment of other monetary benefits is not made to the applicant, Col. Murali Krishna shall again appear before this Court on 12.3.2015.

After the above order was passed, Col. Murali Krishna submits that he is under transfer. However, if Col. Murali Krishna gets his transfer order in the meantime, in that case whosoever will be the OIC Records, Kumaun Regimental Centre, Ranikhet, will appear before this Court in person in case this order is not complied with in toto. Col. Murali Krishna, in that case, will

apprise personally the incumbent OIC Records about the case in detail so that the incumbent OIC Record may not ask for further time and to take the plea that since he has been newly posted he is not aware about the case.

Since so much water has been flown from the date the judgment and order of this Tribunal has been passed in T.A. No. 63 of 2010 but its implementation in its letter and spirit has not yet seen the light of the day, this Court has no option but to observe that if, by the next date, the aforesaid judgment and order is not complied with, this Court will have no other option but to take a serious note of it to look into the matter and to impose costs on the guilty officer, whosoever he may be, to be deducted from his salary.
