No 11 of 2013 (Navy) (Annexure-A (1) none of which has been paid to the applicant till date.	
	A perusal of the relief claimed by the applicant shows that	
	he has approached the Tribunal for the same relief which has	
	already been granted in earlier T.A. (supra) except rounding of	
	disability in accordance with the pronouncement of Hon'ble	
	Apex Court dated 10 th December 2014 in the case of <i>Union of</i>	
	India and Ors vs. Ram Avtar & ors (Civil Appeal No 418	
	of 2012).	
	Technically saying, the O.A. seems to be not	

maintainable for the reason that the provisions contained in Order 2 Rule 2, Code of Civil Procedure to claim whole relief while preferring petition seems to be violated. However so far as rounding of disability pension is concerned, since the claim of the applicant is based on Apex Court judgment, we give liberty to the applicant to approach the appropriate forum afresh, if so advised, but question with regard to payment of interest and arrears in pursuance to earlier judgment of the Tribunal (supra) seems to be not maintainable for the reason that the issue which has already been settled by earlier T.A. (supra) and relief claimed has been granted, cannot be raised again in another petition. The applicant has option to move appropriate application in accordance with provisions contained in Armed Forces Tribunal Act, 2007 or before any other forum, but so far as second petition for compliance of earlier judgment is concerned, the same is not maintainable. The analogy may be drawn from the settled proposition of law that judgment and decree passed in an earlier suit cannot be subject matter of another suit, being barred by constructive res judicata and being hit by Section 11, Code of Civil Procedure.

In view of the above we feel that the O.A. is not maintainable and deserves to be rejected with liberty to approach appropriate forum, if so advised.

It is accordingly **rejected** with liberty aforesaid.

	has not served for 15 years which is minimum pensionable service, as	
	such the husband of the applicant was not authorized service pension.	
	Therefore, the applicant is also not being paid the family pension.	
	Keeping the fact that the applicant's husband has served only for	
	7 years and 63 days, she does not seem to be entitled for family	
	pension in view of Para 132 of the Pension Regulations for the Army	
	Part-I (1961). For convenience, Para 132 of the Pension Regulations is	
	reproduced as under:	
	"132. The minimum period of qualifying service (without weightage) actually rendered and required for earning service pension shall be 15 years."	
	Learned counsel for the applicant submitted that since the	

applicant's husband was discharged on medical ground, as such he was entitled to disability pension. However, from perusal of the record, it appears that neither in the relief nor in the grounds, the applicant has prayed for payment of disability pension of her husband, hence it will not be appropriate to look into the matter at this stage.

Accordingly, the O.A. lacks merit and is dismissed with liberty to the applicant to approach appropriate forum, in accordance with law, for payment of disability pension.
