Office is directed to explain as to why this case has been registered before the application for condonation of delay was allowed.

We have also come across with the order dated 6.3.2013 wherein it is ordered that the pleadings are complete and the case had been directed to be listed for hearing.

We are of the view that unless and until the application for condonation of delay is allowed, condoning the delay in filing the Original Application, the Original Application cannot be registered and treated to be an Original Application in the eyes of law.

Shri Lalit Kumar, learned counsel for the applicant, states that he intends to file a better application under Section 5 of the Limitation Act and prays four weeks' time to file the same after serving a copy of the same on learned counsel for the respondents. If the application under Section 5 of the Limitation Act is filed within the time, as prayed by learned counsel for the applicant, the respondents may file objection, if any, within two weeks thereafter.
