Counsel for respondent no. 4, who appeared on behalf of the wife of the deceased Army personnel Sep Anurag Kumar Chaturvedi, that O.A. is not maintainable.</p> <p>Submission of Ld. Counsel for respondent no. 4 is that under the Armed Forces Tribunal Act, 2007, only those persons who are subject to Army Act may approach the Tribunal, serving or retired from armed forces, their dependents, heirs and successors.</p> <p>On the other hand, Ld. Counsel for the applicant submits that the O.A. is maintainable since the matter relates to retiral benefits/special family pension of the deceased army personnel, which can be apportioned to the beneficiaries.</p> <p>We have heard Ld. Counsel for the parties and perused the record.</p> <p>Regulation 228 of the Pension Regulations of the Armed Forces provides that in the event of death of army personnel, special family pension may be apportioned amongst the dependents, heirs and successors of the army personnel by the competent authority. Accordingly there appears no doubt that applicant may claim benefits from the special family pension. A case has been made out that the deceased army personnel were entitled to family pension and the pension to be paid to him is special family pension.</p> <p>Keeping in view the fact that the applicant is claiming relief in view of statutory provision, i.e. Regulation 228 (supra), we are of the view</p>

that the O.A. is maintainable.

So far as argument of Ld. Counsel for respondent no. 4 is concerned, it is a question to be heard and decided on merit. Objection raised by Ld. Counsel for respondent no. 4 is overruled.

Whether the applicant is successor, dependent or heir of deceased army personnel is question to be decided on merit.

M.A. No. 82 of 2016 is disposed of accordingly.</p> <p><u>O. A. No. 115 of 2015</u></p> <p>Order sheet shows that time was granted repeatedly to the counsel for the State of Madhya Pradesh to file counter affidavit. It is almost fourth time that Ld. Counsel for the state of Madhya Pradesh (Shri Swapnil Ganguli) has prayed to file counter affidavit. Ld. Counsel Shri Swapnil Ganguli submitted that he is appearing for the first time.</p> <p>Appearance for first time by counsel does not mean that the time granted earlier shall lose its effectiveness. Change of counsel is prerogative of the Govt and Courts/Tribunals are not concerned with it. Orders passed earlier in view of request made should have been complied with, with regard to filing counter affidavit by the State of Madhya Pradesh. There appears to be inordinate delay on the part of Govt of Madhya Pradesh. Army has already filed its counter affidavit according to which applicant suffered injury as battle casualty but the State Govt of Madhya Pradesh declined to grant compensation to the applicants on the ground that the applicants are not entitled to compensation in accordance with circulars. Such action on the part of State of Madhya Pradesh seems to be unjustified.</p> <p>It is submitted that earlier Ld. Counsel Shri D.K. Pandey appeared</p>

for the State of Madhya Pradesh and he was replaced by Shri Swapnil Ganguli.

Accordingly as a last chance State of Madhya Pradesh is granted three weeks time to file counter affidavit subject to payment of Cost of Rs 10,000/-. The Chief Secy, State of Madhya Pradesh shall ensure that the cost is deposited within six weeks in the Registry. The applicant shall be entitled to withdraw the amount of cost.

One week thereafter is granted to the applicants to file rejoinder affidavit, if any.

List this case on **18.02.2016** for orders.

Registrar shall send a copy of present order to the Chief Secy, Govt of Madhya Pradesh within a week.

Needless to say that in case counter affidavit is not filed, the case shall be proceeded ex parte since affidavit with regard to other parties have been exchanged.

Counsel for the applicant has invited attention to Special Bench Judgment reported in <i>L Chandra Kumar vs Union of India</i> reported in (1997) 3 SCC 261 wherein their Lordship has held that policy decision may be impugned before the Tribunal and may be struck down. Relevant para 93 of the decision is reproduced as under:</p> <p><i>"93. Before moving on to other aspects, we may summarize our conclusions on the jurisdictional powers of these Tribunals. The Tribunals are competent to hear matters when the vires of statutory provisions are questioned. However, in discharging this duty, they cannot act as substitutes for the High Courts and the Supreme Courts which have, under our constitutional set-up been specifically entrusted with such an obligation. Their function in this respect is only supplementary and all such decisions of the Tribunals will be subject to scrutiny before a Division Bench of the respective High Courts. The Tribunals will consequently also have the power to test the vires of subordinate legislations and rules. However, this power of the Tribunals will be subject to one important exception. The Tribunals shall not entertain any question regarding the vires of their parent statutes following the settled principle that a Tribunal which is a creature of an Act cannot declare that very Act to be unconstitutional. In such cases alone, the High Court concerned may be approached directly. All other decisions of these Tribunals, rendered in cases that they are specifically empowered to adjudicate upon by virtue of their parent statutes, will also be subject to scrutiny before a Division Bench of their respective High Courts. We may add that the Tribunals will, however, continue to act as the only courts of first instance in aspect of the areas of law for which they have been constitute. By this, we mean that it will not be open for litigants to directly approach the High Courts even in cases where they question the vires of statutory legislations (except, as mentioned, where the legislation which creates the particular Tribunal is challenged) by overlooking the jurisdiction of the Tribunal concerned".</i></p> <p>This is a fit case for adjudication.
