Counsel for the applicant and perusal of record, we are of the impression that no reference as required under Section 120 (ii) of the Army Act 1950 appears to have been made in this case. This case is not one where a grave urgency for immediate action is needed, so that the requirement for a reference could be dispensed with. Secondly, Section 69 of the Army Act which applies in this case invariably requires reference from the office empowered to convene a District Court Martial or a Summary General Court Martial, which appears to be absent in the present case. This infirmity goes to the root of the matter and is not a mere irregularity.</p> <p>No doubt, Ld. Counsel for the Respondents submitted that although in the review of the Summary Court Martial Proceedings, the award of imprisonment of two months has been reduced to one month, but there is no disposal of the Statutory Complaint submitted by the applicant so far. He has drawn our attention to the provisions of Para 21 of the Armed Forces Tribunal Act, 2007 for contending that unless the applicant avails of his Statutory remedy, which the applicant has initiated on 20.01.2016, proceedings before the Tribunal</p>

are barred. Our tentative view on a plain reading of the said provision is that the Tribunal is only “**ordinarily**” restrained from entertaining an Original Application, unless the applicant has availed of the alternate remedy but there is no absolute bar is an extraordinary situation when the Tribunal is of the view that there is a jurisdictional illegality. However this question can be examined in depth at the time of hearing of this application.

We accordingly admit the application.

Ld. Counsel for the Respondents is allowed four weeks time to file a Counter Affidavit. Rejoinder Affidavit, if any, may be filed by Ld. Counsel for the Applicant within two weeks, thereafter.

It is further submitted that the above mentioned APAR was recorded very late in contravention of Office Memorandum issued by Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training dated 16.02.2009 (Annexure A-6) of Original Application as the Annual Confidential Report by the Reporting Officer was not submitted within the stipulated period of 30 days and by the date required.</p> <p>It was further submitted that assessment of applicant's overall grading on 'Personal Attributes' which was initially assessed as '5' has been scored out and replaced by '4' and similarly the over all grading and 'Functional Competence' grading which were initially assessed as '5' have also been scored out and replaced by '4', so as to make the</p>

performance of the applicant “below average” as a grading of ‘5’ is considered as “average”. Thus it is submitted, indicates the malafide on part of Respondent No. 4 towards the applicant.

We find that the statutory complaint to the Central Government as provided in Section 27 of Army Act, 1950 read with para 364 of the Regulations for the Army (Volume - 1) has not been availed by the applicant, though the applicant has made a Non Statutory Complaint to the competent authority (DGQA).

As one of the contentions of Ld. Counsel for the applicant is that except for the impugned APAR which had awarded a grading of ‘4’, the applicant had received favourable reports from different superior officers who have earlier reported in his case, we direct the respondents to file a Counter Affidavit and also to produce all APARs of the applicant on the ranks of Lt Col & Colonel before the Court for its perusal.

The applicant is also permitted to prefer a statutory complaint to the Central Government within three weeks and in case the applicant prefers a Statutory Complaint for redressal of his grievances, the competent authority shall decide the same expeditiously by a reasoned and speaking order.
