Let Director, DSC, New Delhi be present before the Tribunal on the next date of hearing i.e. 06th November 2019 to explain the reason as to why the order under execution has not been complied with till date, despite there being costs imposed at different stages, as reflected in our orders from time to time, while dealing with the instant Ex. Application. Copy of this order be provided to learned counsel for the respondents for further transmission to the concerned authority for its compliance.
