Counsel for the respondents.</p> <p>In this case no counter affidavit has been filed.</p> <p>Brief facts of the case are that the applicant was enrolled in the Army on 05.08.1970 and was tried by Summary Court Martial under Section 46 (a) and 40 (c) of the Army Act, 1950. He was dismissed from Army w.e.f. 17.03.1987. Feeling aggrieved with the sentence awarded by the SCM, wife of the applicant submitted applications dated 03.08.2021 and 04.09.2021 to respondent No. 4 seeking documents of the applicant. The Respondents no. 4 replied that documents pertaining to the applicant have been destroyed. This O.A. has been filed after a prolonged delay.</p> <p>There is a delay of more than 32 years in filing Original Application through which prayer has been made to set aside SCM proceedings and grant of service pension.</p> <p>During the course of hearing, learned counsel for the respondents submitted that the applicant was tried by Summary Court Martial.</p> <p>It is argued by learned counsel for the applicant that the applicant was not aware about the rules and regulations and therefore, he could not approach to this Tribunal and he filed this O.A. in this Tribunal on 01.06.2022.</p> <p>Learned counsel for the applicant further submitted that delay in filing Original Application is not deliberate, but on account of poverty and aforesaid reasons, therefore, the same should be condoned.</p> <p>On the other hand, learned counsel for the respondents has vehemently opposed the prayer and has submitted that there is a long delay of more than</p>

32 years and the same has not been properly and satisfactorily explained as the applicant has not assigned any cogent and convincing reason for not approaching the Tribunal earlier.

Having heard submissions of learned counsel of both sides and considering the facts and circumstances of the case, we find that inordinate delay of more than 32 years has not been properly and satisfactorily explained.

Needless to say, in a matter where Original Application is not filed within time, applicant is required to explain delay on day to day basis, which applicant has miserably failed and, therefore, he is not entitled to benefit of his so called poverty and nourishing his family.

In view of the above, delay is not liable to be condoned, therefore delay condonation application is **rejected**.

Original Application being time barred is also **rejected**.
