Counsel for the respondents submits that in compliance of order dated 13.02.2017 in Original Application No. 244 of 2014 the P.P.O. has been issued with its copy to the applicant. Thus, she submits that so far as the compliance is concerned, the same has been done by the respondents.</p> <p>In reply, the Ld. Counsel for the applicant submits that respondents were under obligation to comply with the order within three months from the date of order which they did not do, therefore, they are liable to pay interest also on the amount payable to the applicant which is not mentioned in the P.P.O. He further submits that P.P.O. was directed to State Bank of India, Chandni Chowk Branch, New Delhi which was later forwarded to Punjab National Bank, Haldwani Branch. His further submission is that despite the P.P.O. being forwarded to the Haldwani Branch of Punjab National Bank the Bank is not crediting the amount in applicant's account.</p> <p>We have gone through the Execution Application and we find that applicant's grievance is regarding non-payment of interest on the amount of back wages as well as non-compliance of the P.P.O. by Haldwani Branch of Punjab National Bank. So far as the payment of interest on amount of back wages is concerned, there is no mention in the order under execution and therefore, the same is not payable to the applicant.</p> <p>As regards no crediting amount in applicant's account the Haldwani Branch of Punjab National Bank is not a party in the Execution Application.
