Heard Shri Manoj Kumar Awasthi, learned counsel for the applicant and Shri Anshuman Srivastava, learned counsel for the respondents.</p> <p style="text-align: center;"><u>M.A. No. 969 of 2019</u></p> <p>2. The Original Application has been filed with delay of 26 years, 02 months and 15 days.</p> <p>3. Submission of learned counsel for the applicant is that it is a pensionary matter in which bar of limitation is not applicable. His further submission is that delay in filing Original Application is not deliberate, but on account of reasons stated in affidavit filed in support of application.</p> <p>4. Per contra, learned counsel for the respondents submits that explanation of delay offered by the applicant is not sufficient as delay has not been satisfactorily explained on day-to-day basis.</p> <p>5. Upon hearing learned counsel for both sides and considering the facts and circumstances of the case, we find that cause shown is sufficient.</p> <p>6. Accordingly, delay is condoned.</p> <p>7. The O.A. has already been admitted and registered vide order dated 14.01.2020.</p> <p style="text-align: center;"><u>O.A. No. 78 of 2020</u></p> <p>8. The instant Original Application has been filed on behalf of the applicant under Section 14 of the Armed Forces Tribunal Act, 2007, whereby the applicant has sought following reliefs:-</p> <p style="padding-left: 40px;">“(a) To issue/pass an order or directions to set aside/quash the order dated 03.10.2019 passed by respondent no. 3.</p> <p style="padding-left: 40px;">(b) To issue/pass an order or directions to respondents to grant</p>

Disability Element Disability Pension element @ 20% with effect from date of discharge i.e. 31.03.1993.set aside/quash the order dated 03.10.2019 passed by respondent no. 3.

(c) To issue/pass an order or directions to respondents grant benefits of Rounding off Disability Element of Disability Pension @ 20% to 50% for life to the applicant and pay due arrears including consequential benefits with interest @ 12% p.a. till final payment is made.

9. Brief facts of the case giving rise to this application are that applicant was enrolled in the Indian Army on 04.03.1969 and after having served for more than 24 years, he was discharged from service in low medical category 'S1H1A1P2(P)E1' on 31.03.1993. Prior to discharge from service, applicant was brought before Release Medical Board (RMB) on 30.11.1992 which assessed the applicant to be suffering from 'ESSENTIAL HYPERTENSION MILD 401' @ 20% for life aggravated by military service due to stress and strain. Disability pension claim preferred by applicant was rejected on 17.12.1993. Thereafter, first and second appeals preferred against rejection of disability pension claim were also rejected vide orders dated 08.01.1994 and 03.10.2019 respectively. It is in this perspective that this O.A. has been filed for grant of disability pension.

10. Learned counsel for the applicant submitted that the applicant was enrolled in the Army in medically and physically fit condition and there is no note in his service documents with regard to suffering from any disease prior to enrolment, therefore, any disability suffered by the applicant after joining the service should be considered as attributable to or aggravated by military service and the applicant should be entitled to disability pension. Learned counsel for the applicant further submitted that disability pension claim of the applicant has been rejected in a cavalier manner without assigning any meaningful reason. Further submission of learned counsel for the applicant is that since the aforesaid disability is due to stress and strain related rigors of military service therefore as per Release Medical Board it has been regarded as aggravated by military service. He pleaded for disability pension to be granted to applicant.

11. On the other hand, learned counsel for the respondents submitted that since RMB has declared the applicant's disability as NANA, he is not entitled to disability pension. His further submission is that the competent authority has rightly rejected applicant's disability pension claim on the ground of disability being originated in peace area and being not related to military service, therefore, O.A. deserves to be dismissed.

12. Heard learned counsel for the parties and perused the material placed

on record. We have also gone through the RMB and the rejection order of disability pension claim. We have seen that the disability 'ESSENTIAL HYPERTENSION MILD 401' was assessed @ 20% for five as aggravated by military service but the pension sanctioning authority and appellate authorities have not accepted aggravation factor. The question before us is simple and straight i.e. - is the disability of applicant attributable to or aggravated by military service?

13. The law on attributability of a disability has already been well settled by the Hon'ble Supreme Court in the case of ***Dharamvir Singh Vs. Union of India and Ors***, (2013) 7 SCC 213. In this case the Apex Court took note of the provisions of the Pensions Regulations, Entitlement Rules and the General Rules of Guidance to Medical Officers to sum up the legal position emerging from the same in the following words:-

"29.1. Disability pension to be granted to an individual who is invalided from service on account of a disability which is attributable to or aggravated by military service in non-battle casualty and is assessed at 20% or over. The question whether a disability is attributable to or aggravated by military service to be determined under the Entitlement Rules for Casualty Pensionary Awards, 1982 of Appendix II (Regulation 173).

29.2. A member is to be presumed in sound physical and mental condition upon entering service if there is no note or record at the time of entrance. In the event of his subsequently being discharged from service on medical grounds any deterioration in his health is to be presumed due to service [Rule 5 read with Rule 14(b)].

29.3. The onus of proof is not on the claimant (employee), the corollary is that onus of proof that the condition for non-entitlement is with the employer. A claimant has a right to derive benefit of any reasonable doubt and is entitled for pensionary benefit more liberally (Rule 9).

29.4. If a disease is accepted to have been as having arisen in service, it must also be established that the conditions of military service determined or contributed to the onset of the disease and that the conditions were due to the circumstances of duty in military service [Rule 14(c)]. [pic]

29.5. If no note of any disability or disease was made at the time of individual's acceptance for military service, a disease which has led to an individual's discharge or death will be deemed to have arisen in service [Rule 14(b)].

29.6. If medical opinion holds that the disease could not have been detected on medical examination prior to the acceptance for service and that disease will not be deemed to have arisen during service, the Medical Board is required to state the reasons [Rule 14(b)]; and 29.7. It is mandatory for the Medical Board to follow the guidelines laid down in Chapter II of the Guide to Medical Officers (Military Pensions), 2002 - "Entitlement: General Principles", including Paras 7, 8 and 9 as referred to above (para 27)."

14. In view of the settled position of law on attributability/aggravation, we

find that the RMB has denied attributability/aggravation to the applicant only by endorsing that the disability of applicant arose in peace area and the said disability having no close time association with stress/strain of service in Fd/HAA/CI Ops. We feel that such a discrimination between peace posting and a posting to Field/High Altitude Area/Counter Insurgency Operations amounts to saying that there is no stress and strain of military service in peace area, which is not the absolute truth. It is trite law that any disability not recorded at the time of recruitment must be presumed to have been caused subsequently, and, unless proved to the contrary to be a consequences of military service. In this particular case the disease has in fact been aggravated by conditions of service. The benefit, therefore, shall be rightly extended in favour of the applicant. In the instant case, since the applicant was found to be suffering from the aforesaid disability when he had put in more than 17 years of service, therefore the RMB has rightly assessed applicant's disability as aggravated by military service. We are, therefore, of the considered opinion that the benefit of doubt should be given to the applicant as per the Hon'ble Supreme Court judgment of **Dharamvir Singh** (supra) and the disability of the applicant should be considered as aggravated by military service.

15. In view of the above the applicant is held entitled to 20% disability element for life rounded off to 50% disability element for life in terms of Hon'ble Apex Court judgment of **Union of India and Ors vs. Ram Avtar & Ors**, Civil Appeal No 418 of 2012 dated 10th December 2014) with effect from 01.01.1996 and not from the date of discharge as policy for rounding off of disability element came into existence w.e.f. 01.01.1996, but due to law of limitations as held in Hon'ble Apex Court judgment in the case of **Shiv Dass vs Union of India & Ors**, reported in 2007 (3) SLR 445, applicant shall be entitled to arrears (duly rounded off) of disability element three years prior to filing of this O.A. i.e. w.e.f. 18.12.2016 as this O.A. was filed on 18.12.2019.

16. As a result of foregoing discussion, the O.A. is **allowed**. The impugned orders are set aside. The respondents are directed to pay aforesaid disability element alongwith arrears within four months from today.

17. Default will invite interest @ 8% p.a.

18. No order as to costs.

19. Pending applications, if any, are disposed off.
