Eligibility

Research Students and law students pursuing 3-year and 5-year law degree course from any recognized College/Law School/University

How to Apply?

Interested students may send their applications in the enclosed format, by 01st February in case of the Summer Internship Programme and 01st October in case of Winter Internship Programme.

Application received after the last date may not be considered and no correspondence shall be entertained in this regard. An incomplete application will not be entertained.

Selection

All these applications will be scrutinized and the actual offer will be sent to the selected students subject to the availability of slot and approval of the Competent Authority.

The maximum number of slots to be offered to the students shall be decided by the Competent Authority.
